Awards will be available at the conclusion of the trial. Ribbons are awarded for Qualifying Score, High in Class, and New Titles.

## Venue:

Exhibitors will be crating in their vehicles. **NW K9 Sniffers Club** reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog.

### **Notice to Exhibitors:**

- Refunds requested prior to the closing date will be processed within 7 days of the trial to the original payment method, less \$5/entry.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused, or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children, and guests. Any exhibitor whose dogs, children, and guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times, except when competing in TL or SD.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick-up after your dog.
- BIS will run last and must wear protective garment.
- All entries must be paid before they are considered valid. A declined payment does not constitute a valid entry.
- Northwest K9 Sniffers Club reserves the right to refuse any entry without cause or explanation.
- Check-in will begin at 8:30 am each day. The briefing will begin at 9:00 am each day, with the first dog on the line immediately following the briefing.
